All,

Currently, we have an element in Monroe supporting the PD there as they facilitate operations for the demonstration through their City. At 1:30, two elements will arrive in Bothell to support their operations for the demonstration at a local park. We are prepared to support Mount Lake Terrace this evening during their candle light vigil, but we are not yet planning to deploy for that event.

I have authorized the deployment of the team on Friday in support of Redmond. Their PD will be working two different demonstrations, one at noon and one at 4:30pm.

Team leadership is keeping a close eye on all the tactical members for fatigue/burn out. We are working in periods of rest for each element when we can. More to follow. Please let me know what questions you have. Glen
