**\*MAY 30<sup>TH</sup> DEPLOYMENT, I WAS CARRYING THE RDF, LESS LETHAL TIPMAN MODEL #98 CHEMICAL LAUNCHER TO INCLUDE OC-PEPPER ROUNDS, INERT MARKING ROUNDS, GREEN PAINT MARKING ROUNDS & INERT BLAST BALLS.**

**THE BRIEFING FROM RDF COMMANDER LT. ELMORE @ 1000 AT DISTRICT HEADQUARTERS. TRANSPORTED TO CENTURY LINK FIELD TO STAGE AND AWAIT DEPLOYMENT ORDERS. DEPLOYED TO DOWNTOWN SEATTLE PER RDF COMMAND TO ASSSIST AT THE REQUEST OF SEATTLE POLICE DEPARTMENT. DISTRICT 2 RDF DEPLOYED TO AREA OF 4<sup>TH</sup> AVE & OLIVE WAY. AT APPROXIMATELY 1500 HOURS. DISTRICT 2 RDF (BLUE & GREEN TEAMS) PROVIDED ASSISTANCE TO THE SEATTLE POLICE DEPARTMENT BETWEEN THE AREAS OF 4<sup>TH</sup> & OLIVE, STEWART STREET; ULTIMATELY ASSISTING WITH PUSHING THE ASSUALTIVE AND RIOTING CROWD TOWARD THE NORTH EAST IN AN ATTEMPT TO MOVE THE CROWD OUT OF THE CITY.**

**AT APPROXIIMATELY 1745 HOURS, MY SQUAD LEADER (SGT. STEWART #221) DEPLOYED THE BLUE SQUAD TOWARD THE AREA OF 6<sup>TH</sup> & WESTLAKE, 6<sup>TH</sup> & STEWART STREET TO ASSIST FELLOW STATE PATROL RDF TEAM MEMBERS BEING MET WITH FROZEN WATER BOTTLES, FIRE EXTINGUISHERS, ROCKS, BRICKS, GREEN LAZER LIGHTS BEING DEPOLYED AGAINST THEM.**

**AS I ARRIVED TOWARD THE INTERSECTION OF 6<sup>TH</sup> & STEWART I NOTICED MASS AMOUNTS OF THESE ITEMS BEING THROWN AT LAW ENFORCEMENT. I WAS INFORMED THE CROWD'S**

ORDER TO DISPERSE WAS LAWFULLY GIVEN BY LAW ENFORCEMENT; WHICH THEY FAILED TO ACKNOWLEDGE. WHEN ATTEMPTING TO PUSH THE CROWD THEY BEGAN TO THROW FROZEN WATTER BOTTLES, BRICKS, ROCKS, METAL DEBRIS AND FIRE EXTINGUISERS AT LAW ENFORCEMNT. WHILE ASSISTING TO PUSH THE ASSAULTIVE AND DESTRUCTIVE RIOTTING PROTESTERS I UTILIZED INERT BLAST BALLS AND OC-PEPPER ON THEM TO GAIN COMPLIANCE AND MOVE THEM AWAY. AFTER DEPOLYING 3 BLAST BALLS, ONE HOPPER OF OC-PEPPER ROUNDS THE CROWD MOVED TOWARD 6<sup>TH</sup> & WESTLAKE. WHILE MOVING THAT DIRECTION I DEPLOYED 1 ADDITIONAL BLAST BALL AND NUMEROUS MORE OC-PEPPER ROUNDS AS I IDENTIFIED AN ASSUALITIVE BEHAVIOR FROM AN AGGRESSOR WITH A GREEN LAZER, AS WELL AS ONE THROWING HARD OBJECTS TOWARD MYELF. (FIRE EXTINGUISHER). AFTER DEPLOYING THESE ITEMS THE SUBJECTS RETREATED INTO THE CROWD AND DISAPPEARED FROM MY SIGHT.

AT APPROXIMATELY 2030 HOURS, RDF TEAMS CONTIUNED TO SUPPORT THROUGHOUT THE NIGHT IN THE AREA OF 8<sup>TH</sup> & PIKE STREET WHERE WE IDENTIFIED A SUBJECT THROWING A BRICK TOWARD OUR TEAM. THE SUBJECT WAS IDENTIFIED WTH A BLUE JEAN JACKET AND I NOTICED THE BRICK BEING THROWN IN THE AIR. AS HE THREW THIS I LAUNCHED OC-PEPPER ROUNDS AT HIM AND STRUCK HIS LOWER BODY AND LEGS. THE SUBJECT FLED THE AREA OUT OF MY SIGHT.

ALL WSP RDF TEAM MEMBERS CLEARAD THE CITY OF SEATTLE AT APPROXIMATLEY 2330 HOURS.

**Summary of events:**

We were initially deployed to protect the Meydenbauer building on NE 6<sup>th</sup> Street between 110<sup>th</sup> and 112<sup>th</sup> Avenue. Within the hour, we were re-deployed to assist Bellevue PD on Bellevue Way NE and NE 4<sup>th</sup> Street with a large group that had gathered in protest. We rotated with Bellevue PD maintaining crowd control for the next several hours. After being given dispersal orders, All RDF teams at our location began to direct the crowd south on Bellevue Way from NE 4<sup>th</sup> Street. When the crowd failed to comply, Bellevue PD began deploying munitions as we continued to push the crowd south toward NE 2<sup>nd</sup> Street. The crowd again gathered at NE 2<sup>nd</sup> Street and was given a 10 minute dispersal order. After failing to disperse again, munitions were deployed to push the crowd further south. At this point, a protester picked up a munition that had been deployed and was attempting to throw it back at the RDF teams. I deployed my .40mm launcher that was loaded with a direct impact blue nose munition and struck the protester in the left arm. The protesters continued to move south and eventually dispersed.

**Summary of events:**

On May 31, 2020 at approximately 2100 the Eastside RDF team was deployed and manning a skirmish line with Bellevue Police at the intersection of Bellevue Way and NE 2<sup>nd</sup> Street in Bellevue. The order had previously been given to the defiant crowd to disburse while they were occupying Bellevue Way and 4<sup>th</sup> Street.

Crowd management munitions were deployed to disburse the crowd. While the skirmish line was holding, I saw a male in all black, including a face covering, reach down and pick up a canister of a CS Triple Chaser and cock his arm back.

With an OC direct impact 40mm less lethal impact round I acquired a sight picture and deployed the munition. The subject threw the CS canister back at the skirmish line to my left. After I shot the round I watched it travel directly to the subject, approximately 30-35 yards in front of me. The impact round struck the subject center mass to his left to front side, he was quartered to his right. I saw the subject wince in pain from the impact and then run to the park behind him, to our right.

While I was reloading the launcher I lost sight of the subject as his ran into the smoke and darkness.

On Sunday May 31, 2020 Trooper Armstrong #404 deployed with the District Two (D2) Rapid Deployment Force (RDF). Trooper Armstrong was acting in his capacity as a Chemical Agent Response Team (CART) member. Trooper Armstrong was deployed with the Tim Model 98 Chemical Launcher.

At 1200 hours WSP RDF arrived to Centurlink Field for briefing from RDF Commander, Lt. Elmore #78. WSP RDF team was transported to the Seattle Fire Station #32 near 5<sup>th</sup> and James Street to await deployment orders. Trooper Armstrong remained at this location until approximately 1700 hours. We were then transported to Seattle Police West Precinct to await deployment order.

At approximately 1730 hours, Trooper Armstrong deployed to Bellevue Square Mall to stop protesting and rioter who broke into the businesses in the area as well as the Bellevue Square Mall.

Trooper Armstrong enter the mall and was assigned to a static post through the amll until such a time the National Guard team arrived to relieve him. Trooper Armstrong then deployed to the area of Northeast 6<sup>th</sup> Street and Bellevue Way to keep the street closed from previous orders to disperse; which were given by the Chief of Bellevue Police Department.

Trooper Armstrong assisted other RDF members who were already on post in the area with the containment until such time he was released for the night which was approximately at 2330 hours.

**Summary of events:**

**On 5/30/2020, I was assigned to the Blue Squad of the Washington State Patrol District 2 RDF team as the Grenadier/Chemical Agent Response Team. I was carrying a Defense Technologies/ Lewis Machine and Tool (LMT) 40mm single shot launcher. I was carrying a full CART vest with multiple impact and chemical agent munitions that I am certified to use and am also certified as an Instructor through Defense Technology.**

**On May 30, 2020 at approximately 1500 hours I Trooper Brian Gavin badge #736 was deployed to the area of 5<sup>th</sup> and Olive in Seattle. A dispersal order had already been given. When asked to assisted SPD. The protesters were refusing and throwing water bottles, and rocks. An agitator that was exhibiting assaultive behavior inciting the protesters and refusing orders continued to approach the line. I was given a direct order to deploy an impact round to gain compliance from the white male agitator. I deployed a green marking impact round and struck the protestor. The protestor retreated into the crowd.**

**When in the approximate area of 6<sup>th</sup> and Westlake the protesters were hostile and exhibiting assaultive behavior. The protestors were throwing rocks, bottles of water, and a fire extinguisher. There was a protester in the ground attempted to burn retina of officers with a**

green laser. A male in a black T-shirt threw a debris at the line. I deployed marking impact round the stuck the wall directly behind the protestor causing him and the group around him to disperse.

A protestor with a back and red top threw a debris from an elevated platform entrance to a business. I deployed a green marking impact round that struck the wall behind protestor.

A protestor approached the line and throw a bottle. I observed him reach his arm back in throwing motion in an assaultive manner. I deployed and OC marking impact round that stuck the left shoulder. The protestor retreated into the crowd.

A male protestor in dark clothing attempted to pick up a triple chaser that had been deployed to throw back at the line of officers. I deployed a blue nose impact round the struck the right leg of the protestor. The protestor retrieved back to the crowd.

At approximately 1950 hours in the area of 7<sup>th</sup> and Pike a male subject in dark clothing threw a brick that struck an officer. I deployed a blue nose impact round. The subject in the dark clothing fled.

We patrolled Seattle intervening the looting and property destruction we observed until our transportation arrived.

Throughout the deployment there was looting, rioting, and assaultive behavior. I observed large amount of property destruction and criminal activity. Numerous mounts of items were thrown.

- For the safety of our personnel, made the decision to remove RDF from Seattle that night.
